# Pension Plan Surplus, Memorandum of Agreement Update and What you can do.

Dear Members,

In recent weeks, you have voiced your frustration and anger about the dispute between the PNA & Unions and the CBC over the MOA, the agreement which sets out the terms for the sharing of future pension surpluses. CBC's position is that the MOA is no longer in force and as such, contends there is no agreement for the sharing of future pension surpluses.

## Breach of Trust and Faith

It is an indefensible position. We believe that CBC's actions demonstrate a significant breach of trust and good faith. We feel strongly that CBC should live up to the terms of the

MOA as negotiated by both parties in good faith more than 10 years ago. The arbitration process triggered by the CBC is costly, unnecessary, and damaging. It will create yet another rift between itself, its employees, and pensioners.

The emotional and financial implications of CBC's actions are significant. At a time when inflation is skyrocketing, members would benefit from the pension surplus distribution.

Clearly, you all agree.
Never before has an issue outraged so many members, and many of you want to take action. We understand that you want to make your voices heard by the CBC. It is

important that we consider the ways to do this, and weigh the efforts required versus potential outcomes.


## PNA Demands to be Heard

intention was to relay what we are hearing from members and insist on action. He heard how the CBC has made PNA members feel disappointed, frustrated, and abandoned, and he acknowledged the financial implications.

While Mr. Dubé believes that PNA members are extraordinary ambassadors for the CBC, he was unable to provide an explanation for CBC's position, pointing to the fact that the issue is currently in arbitration.

## What Happens Next?

Mr. Dubé promised that he would report back to the CBC on his meeting with the board. We appreciate that he took the time to listen to our concerns and look forward to seeing what happens next.

The arbitration will continue, setting the stage for another expensive and prolonged dispute. We also await a decision on our request for a "preservation order". In the meantime, the CBC continues to reap the law-imposed "contribution holiday".

We will continue to make sure the CBC is aware of our position on this crucial matter. We will advocate for your rights and benefits and examine other measures we can take. We hope that the CBC demonstrates that it truly values the PNA as a significant and important stakeholder group by reversing its decision and honouring the MOA.

## National Board Meeting Highlights

Gerry Head President - Ont.



Raj and I recently attended the Board of Directors Meeting of the PNA in Toronto. Gino Piazza, SWO Chapter President and Ontario Regional Board Secretary also attended.

The Board reviewed the audited financial statements for the year ended March 31 as well as the budget for 2022-23. Financially, the Association is in excellent shape.

The Board heard and responded to the results of the national survey that was conducted in February. The survey was designed to look at the following: contact all former CBC employees, collect data to form the basis of recruitment programs, determine if members feel excluded by the Association and enable the Association to contact non-members.

Some interesting facts: 10,164 member pensioners, non-member pensioners and surviving spouses were contacted. Reponses received: members by SurveyMonkey 68%, by mail 31%, non-members by SurveyMonkey 23% and by mail 11%. These numbers are considered significant except the non-members by mail which is consider a poor return.

Results: nine out of ten members are satisfied with the work of the Association in defending their interests, keeping them informed and having someone available to answer their questions.

Over half of the respondents feel that the Association offer social events. Only 5% of the respondents felt excluded by the Association. One in six respondents are interested in volunteering.

The survey asked how would you like any pension surplus to be handled. One third responded suggesting an increase in the indexation of the pension, three percent suggested improvements to

the benefit package, sixty-two percent suggested a lump sum payment.

(NOTE: Any pension surplus can only be distributed by lump sum.)

Fifty percent of surviving spouses are aware that they are eligible to join the Association. Ten percent stated that they would be interested in attending an information session.

Most members are not aware of what it costs to be a member of the Association. Let me help you to understand the formula. Take the percentage 0.0032 and multiply your monthly pension payment. e.g. a monthly pension of \$2100.00 would result in an Association fee of \$6.72 a month or \$80.64 per year.

This yearly fee is tax deductible.

The end result of this survey gives us insight into the feeling of the members and non-members and gives us access to potentially 400 new recruits.

The Memorandum of Agreement continues in arbitration with the next meeting scheduled in September. In the meanwhile, a request has been filed to place the pension surplus on hold to ensure that when we win the arbitration there will be money set aside to pay the award. This request is scheduled for an early June hearing. The amount of the pension surplus is limited to approximately \$45,000,000 (45 million dollars).

A report by the Standing Committee on Equity, Diversity and Inclusion was received by the Board.

This committee is looking at Diversity Awareness Training, a handbook for planning in-person or virtual events and when composing and publishing newsletters. It recommends having speakers address National Board meetings as well as being available for Regional and Chapter meetings. This committee continues to work.

The VP of People and Cultures, Marco Dubé, appeared before the National Board to tell us that the CBC values its retirees. Retirees are the backbone of the CBC and its most vocal supporters.

Mr. Dubé was extensively questioned as to why if retirees are the backbone of the CBC, it continues to deny retirees their rights to the pension surplus?

The meeting ended with an extensive report from Catherine Schellenberg, our recently hired Director of Communications. This report deals extensively with methods to get non-members to join. How can we improve communications with our members, how can we co-ordinate our efforts to inform and recruit?

I would like to leave you with this: we are all in this together and together we can accomplish the most!

# Changes to the Special Assistance Fund

PNA Website.

While there have been some administrative changes, CBC pensioners and employees continue to have access the Special Assistance Fund (SAF) which was established to help cover costs of medical services and devices not covered by group health plans.

Although the amounts and guidelines for the SAF will remain the same, the administration of the plan has undergone some IMPORTANT CHANGES you should note.

- The administrator of the Fund is now Canada Life. It will review all submitted requests to determine eligibility under the guidelines and will ultimately issue payments.
- The form (available on the PNA website) used to make a request for benefits under SAF has changed (SAF REQUEST FORM). You may note among other things that the form indicates the CBC Supplementary Health Care Plan number.

YOU DO NOT NEED TO BE A MEMBER OF THE SHCP TO APPLY FOR AN SAF BENEFIT. The number is used merely to identify someone as a CBC employee or retiree.

 While all requests need to be MAILED to Canada Life, we encourage PNA members to either contact or submit their requests through our national office to ensure they are complete and compliant with the rules.

AT THIS TIME, EMAILED FORMS AND RECEIPTS WILL NO LONGER BE ACCEPTED. PLEASE FORWARD ALL REQUESTS TO:

DEADLINES have been changed. The Consultative Committee reviews requests quarterly usually during the first week of March, June, September and December. In order to have a request approved for payment, requests, along with receipts must be SUBMITTED BY THE FIRST DAY OF THE MONTH PRECEDING THE CCSB MEETING.

## Herbs that repel or attract

Most of us would prefer to deal with garden pests in the most earth-friendly way possible. Many of our most commonly used culinary and medicinal herbs also have the added benefit of attracting or repelling garden creatures, both desirable and undesirable.

Feverfew, once used for the treatment of fever and more recently migraines, will also discourage insects from entering your garden. It is also effective as a moth repellent.

Pennyroyal, from the mint family, was for centuries used for a wide range of medicinal purposes as well as in ancient ceremonies, but did you know that it also repels ants?

Tansy has traditionally been used as an insecticide and insect repellent. In the Middle Ages, it was one of the strewing herbs used on floors, and it was rubbed on meat to keep insects away. When planted in your garden it will help to repel flies.

While catnip and cat grass will most certainly bring felines to your garden, Rue, once used as a protection against witchcraft and magic, will drive them away.

If you wish to attract bees for pollination, then plant Lemon Balm, Borage and Hyssop.

Lavender, Bergamot and Hyssop will bring butterflies to your garden while Bergamot and Pineapple sage will attract hummingbirds.

Many of the so-called working herbs also possess ornamental qualities that will provide visual interest while they rid your garden of pests.
