President Bob Forrow called the meeting to order at 11:15 a.m.

### 1. Welcome and Introductions

President Bob Forrow (Edmonton, AB) welcomed and introduced the Regional Executive comprised of Vice-President Lutz Walsh (Regina), Treasurer Cécile Magnan (Edmonton), Secretary Joanne Skidmore (Regina). Bob thanked Cécile and Joanne for each serving six years in their roles. Also present was Joanne McAdam the President of the Southern Alberta Chapter. The President of the Saskatchewan Chapter, Hartland Jessome, was not able to attend.

### 2. Quorum

Vice-President Lutz Walsh explained the declaration of quorum and the voting procedure for this meeting held via Zoom. We need at least 5% of the membership, 14 members, for quorum and 28 members were present.

### 9. Southern Alberta Chapter Report

The Chapter was complimented on its \$1,000 Christmas Food Bank donation. An explanation was given about how the SAC can make that donation when the national PNA board has said PNA money cannot be used for donations. The SAC situation is an exception granted years ago.

There was some discussion about whether the Chapter could tell members they must be fully vaccinated to attend lunch meetings at a restaurant. A suggestion was made that the Chapter choose a restaurant which requires patrons to be fully vaccinated against COVID-19. The SAC is not likely to hold a meeting until early in 2022.

### 10. Saskatchewan Chapter Report

President Hartland Jessome was not able to attend. There were no questions of the Chapter Vice-President Lutz Walsh. He said the in-person gathering scheduled for October may be postponed due to the increase in COVID-19 cases in Saskatchewan.
