#### PRESIDENT'S REPORT

With the end of COVID restrictions, our normal activities have resumed, and we were able to conduct our fall luncheon in 2022. We look forward to a spring lunch and AGM on May 24. At our fall meeting, two long-standing board members, Lionel Moore and Ernie Nairn, announced their intention to change roles as members of our local executive, and a new president was acclaimed. Two new at-large board members have been recruited, and Denis Collette has recently agreed to serve as interim treasurer. Formal elections for all board positions will be conducted in spring 2024. We have named a regional representative to the recruitment committee, and hope to recruit some new volunteers for other PNA committees. Our membership numbers have increased slightly over the year, and the regional membership level stands at around 215.

Although we contacted our local human resources person and the local Canadian Media Guild president, we did not formally participate in the recent PNA Day/pre-retirement seminars. We will have a presence at any similar future events in the Winnipeg plant.

While Ernie Nairn and Lionel Moore have not disappeared from the PNA scene, we should thank them for their many years of devoted service at the local and national levels. We should also recognize Yvonne Roy, George and Pat Einarson, and Jacquie Machovec for their continuing contributions to the success of our local events.

#### TREASURER'S REPORT

With the end of COVID restrictions, our activities have normalized, and regular expenses have resumed. We started the year with almost \$36000 and ended with almost \$41000 in our bank account.

Our income came from the national office of the PNA (monthly fee rebate and annual recruitment bonus) and the credit union (interest and member's bonus) with a small amount from the spring luncheon (received from non-members). Expenses were related to our fall luncheon (room, meal, and door prizes), two board meetings, and two mailings. After expenses, our bank balance increased by almost \$5000 over the year.
