## Premiums for supplemental health plan about to rise

The national board of directors has approved a recommended increase in the premiums for our supplemental health care plan in 2025. Claims in 2024 have been running higher than the premiums paid by CBC pensioners. The increases vary by province and age group, a reflection of the different levels of provincial prescription drug coverage. The board also approved using some of the plan's historic surplus to keep the national average increase at 4.9 per cent. The CBC will contact plan members to update their premium amounts.

## Pensioners Coalition doesn't take the summer off

Our association is an active partner in the NL Seniors and Pensioners Coalition. During the summer, the coalition held meetings with the provincial ministers responsible for seniors and health. The coalition also met with two NDP MPs, in part to discuss the potential impact if the Alberta government follows through on its plan to leave the Canada Pension Plan. The terms last two years and take effect at our annual general meeting in the spring. Please consider running to help keep our association at its best. # Pension plan surplus distribution déjà vu

Last, and certainly not least, get ready for the latest pension surplus distribution process. And it looks a lot like what we did last year. The CBC will be contacting you soon, seeking your consent to share the pension surplus declared following the Dec. 31, 2023 actuarial valuation. Approximately \$55 million dollars will be shared between 20,000 pension plan members. Like last year, the federal pension regulator (OSFI) requires the consent of two thirds of pensioners. That means you will have to fill out a form like last year's. This time OSFI will recognize the consent for five years. Assuming our pension plan continues to generate large enough surpluses, we will not have to fill out the consent forms for another five years. We'll be in touch to help you out when the CBC circulates the forms.
