Now to the more serious stuff

Change coming for our regional executive

During March, out election committee of Debbie Hussey and Jon Soper put out a call for nominations for the positions of vice-president and treasurer. When the deadline came, only Anne Budgell was nominated for a second term as treasurer. No one was nominated for vice-president.

But the story doesn't end there. Under our bylaws, if no nominations are submitted, the executive can seek volunteers to fill a vacancy. That appeal went out, and Chris O'Neill-Yates was quick to come forward. Thank you, Chris, and thank you Bob Sharpe for your two years as V.P. Chris will start her term as of the Annual General Meeting.

And Our 2025 Annual General Meeting isn't far away

Stay tuned for more on the 2025 pension surplus payouts.

This is a fluid situation, so do pay attention to updates on this year's payments from the 2023 pension surplus distribution and what's likely to be another from the end of 2024. The amount from 2023 is estimated to be roughly \$60 million, including interest.

Here's the national update from mid-March:

"CBC Pension Plan members have begun receiving a notice, either by email or regular mail, advising them they have 30 days from receipt to provide any comments on the surplus distribution to the regulator, the Office of the Superintendent of Financial Institutions (OSFI).

No action is required on your part. This "second notice" advises plan members that CBC is seeking to release the funds from the plan to pay out the members' surplus share. It is a required part of the process established by OSFI and it gives all Plan members a chance to offer comments should they choose to do so.

It will then be up to OSFI to give approval for the distribution of funds.

Assuming the surplus payout is approved, and the funds are released, there is an additional 40-day hold before they can be distributed. We cannot predict when a payout will occur, but it is reasonable to assume it will not be until sometime in late spring or early summer.

Big local effort to turn out the surplus vote

There was a lot of confusion in late 2024 and early this year about what was going on with the voting by pensioners and deferred pensioners to

approve the surplus distribution. The mail-in ballots were delayed by the strike at Canada Post, so the deadline for mailing in consent forms was waived, but not all pensioners realized that.

And many pensioners who emailed in responses (and that was complicated enough) didn't receive confirmations that their votes had been received.

With all that confusion, the national office provided your provincial executive with the names of members whose ballots hadn't been received. The executive contacted almost all those members, and we succeeded in making sure ballots were sent in.

We know many of you made multiple attempts to send your ballots in, thanks for your patience. In the end, the effort across the county paid off, and pensioners approved the surplus distribution. Thank you for hanging in.

Advocacy in action

With the federal election underway, the PNA's National Advocacy Committee is sending members a series of discussion papers, one at a time, to provide you with carefully researched background on issues near and dear to our hearts. They include a summary of where each federal



party stands on the issues, and questions you might want to ask candidates when the opportunity comes up. The papers will come as follows:

- 1. Preserving CBC/Radio-Canada
- 2. Access to quality health care
- 3. Keeping the Canada Pension Plan whole

4. In defence of defined benefit pension plans

- 5. Making ends meet
- 6. The CBC, public broadcasting, and democracy

They'll also be posted on the <u>PNA website</u> and shared on social media.

Also watch for more local and CBC-specific content. Keeping the CBC alive is in all our interests and we'll do our best to keep you in touch with other campaigns aimed at doing just that.

Our advocacy continues in Newfoundland and Labrador

Our organization is an active member of the NL Pensioners Coalition, and part of that work includes meeting with provincial and federal politicians. In the past year, the coalition met with two MPs from this province who were at the time serving as the federal minister responsible for Seniors. Seamus O'Regan announced last summer that he was not running again, and he was replaced by St. John's East MP Joanne Thompson. The coalition met with her in January. Since then, a lot has changed on the federal scene, but the coalition is waiting for the next opportunity to influence how our governments treat seniors.
