And who would have thought that what appeared, not long ago, to be a lock on government for the Conservatives has turned in favour of the Liberals? Pundits are calling this an unprecedented reversal in Canadian politics, but the campaign isn't over. Ultimately, what happens on April 28th is what matters.

What does the election mean for us as retirees? Over the past few weeks, the PNA's National Advocacy Committee has shared six backgrounders on issues of prime importance to pensioners. We've generated talking points for conversations with others, and suggested questions to help you get clarification on where candidates really stand.

Your feedback has been encouraging. With so much "noise" out there, you've told us it's been helpful to have such intelligent and well-researched material. (Let's face it, PNA members are some of the best writers and researchers around!)

It's worth noting that the Advocacy Committee made a conscious decision not to advocate for any one party, but rather to write explainers about each issue and outline where the parties stand. It's been a challenging exercise, as political leaders sometimes have changed long-held positions during the election campaign. We've done our best to keep our material as up to date as possible.

Across the country, many of our members have actively supported the PNA's "Make Your Voice Heard" campaign: writing to their candidates; setting up local events; producing video testimonials; and asking tough questions to hold candidates accountable for their words and actions.

Election Day is almost upon us and, as we all know, anything can change. Keep asking questions. Keep using the materials we've shared. Keep standing up for what matters.

And the most important thing we can do? Vote. All the work means nothing if we don't exercise our rights at the ballot box. Make your voice heard. And help shape our future.

ALMOST THERE: Pension Surplus Update

The payout of the 2023 pension plan surplus has moved one step closer to final approval.

The 30-day period established by the federal pension plan regulator (OSFI) and set out in the Second Notice that was sent to all contributors for comment has been completed. We are now awaiting OSFI's approval to proceed with the payout.

It is still hoped that payments can be made sometime around the middle of June. However, the timing is directly linked to the date OSFI gives its approval and we do not know exactly when that will happen.

In total, about \$60-million will be shared among roughly 20,000 plan contributors. Consistent with the method used last year, payments will be calculated as a percentage of your lifetime plan contributions.

You should also expect to receive the notice regarding the 2024 surplus later this summer.

No action will be required unless you wish to comment. That's because OSFI agreed that retired members will have been deemed to have given their approval for a five-year period.

We will keep you informed as the process moves forward.

One Year In: Embracing the Challenge

There's an old saying: "May you live in interesting times." I won't get into the debate of the origin but whoever first said it may have foreseen the world as it is today.

While the madness south of the border rages on, Canadians are on the eve of choosing our next Parliament. One that will be confronted with a different world than existed less than 6 months ago. A significant issue to be decided is the future of the CBC, our national broadcaster and sponsor of our pension plan. Also, the place where the majority of us spent most of our working lives.

I've had the great opportunity to speak to many of you since I was elected the PNA's National President almost a year ago. I share your concerns about the future and about the impact that actions taken by thoughtless people are having on our lives and on the future of our kids and grandchildren. But I am confident we will persevere.

It's been both a challenging and rewarding year for the PNA. A national mail strike and other technical glitches hampered our ability to get the votes necessary to assure payment of our share of the 2023 pension surplus, but persistence paid off and we got there.



That success is being rewarded by an assurance the 2024 surplus share will also get distributed and that we won't have to go through the angst of yet another vote for another 5 years. By this fall, nearly a quarter of a billion dollars in surplus monies will have been distributed to all pension contributors.

While work on making sure the surpluses get distributed is ongoing, other important work is being done. The National Board agreed on a new three-year strategy it believes will make the PNA more accountable, relevant and accessible. We revitalized four national committees focusing on growing and engaging our membership, improving our communications, being more active and visible on critical issues that effect our members, and embracing the fundamental principles of equity, diversity and inclusion.

These committees are populated with energetic, intelligent and caring members. You'll can read more about the work of these committees elsewhere in this newsletter.

And now for the unapologetic plug. The PNA is formally recognized as the representative body for all CBC retirees. Out of more than 10-thousand CBC retirees, only about 6,000 are members.

While we have a few dedicated parttime staff, the majority of the work we do is performed by volunteers. It's important work. The PNA faces a grim reality that every year we lose about 200 of our colleagues. It's why we place an emphasis on engagement and recruitment. There is plenty of room for retirees to get involved. And if you know of anyone who could be a member and hasn't joined, give them a nudge.

Dues are minimal and the benefit is great.

Need Help Covering Some Health Expenses?

The Special Assistance Fund (SAF) May Help

Did you know there's a fund to help with some medical expenses not covered by your group health plan?

The Special Assistance Fund (SAF) supports CBC employees, retirees, and eligible family with costs for essential medical devices/services—like hearing aids or mobility aids.

Overseen by the Consultative Committee on Staff Benefits (CCSB), applications must meet fund and the Canada Revenue Agency criteria. The claims are processed through Canada Life.

You don't need to be in the CBC PNA Supplementary Health Care Plan to apply. Leave that section blank if it doesn't apply.

Submit your application early—CCSB meets in March, June, Sept & Dec, and Canada Life needs 4 to 5 weeks to process.

Why Membership Growth Matters

Expanding our membership is one of the most important things we can do to protect our pensions and benefits.

A larger and more engaged membership means a stronger voice when advocating on behalf of all retirees. The Standing Committee is committed to monitoring enrolment and ensuring that valuable information and strategies are shared across regions and chapters to support these efforts.

Progress and Opportunities

As of December 31, 2024, our membership stood at 5,855 members out of 10,311 pensioners—a participation rate of 56.8%, up from 52.9% in 2023. This is a significant step in the right direction, but more than 4,000 pensioners remain outside the Association.

Each of us has the opportunity to reach out to these potential members and encourage them to join.

In the coming weeks, you'll receive a communication with practical ideas to help guide conversations with former colleagues who are now retired, as well as current employees nearing retirement. This information will also be available on our website as a resource for all members—so stay tuned!

Enhancing Outreach

Another key initiative is the revision of the PNA's membership brochure, which will be sent to all new retirees. The brochure is often the first point of contact we have with new pensioners, and it must clearly convey the importance of joining the Association.
